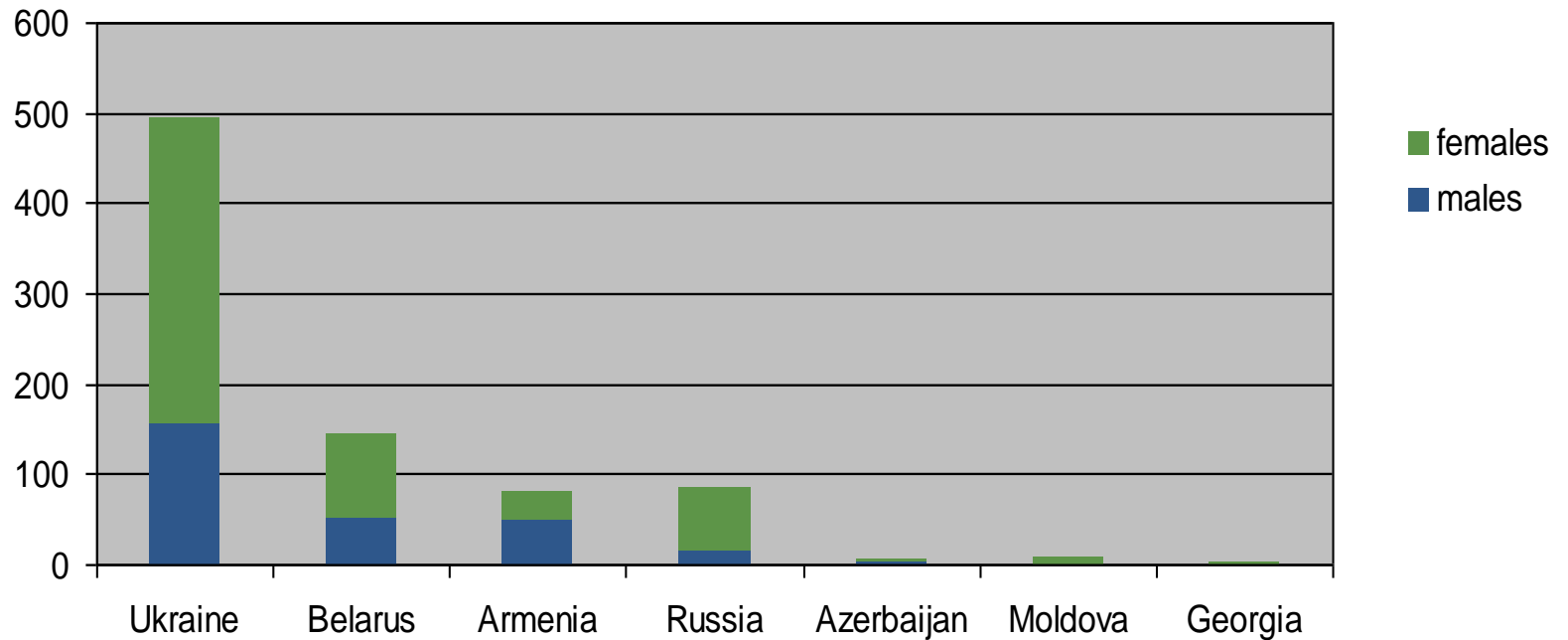

Immigration for permanent residence to Poland by citizenship, 2010

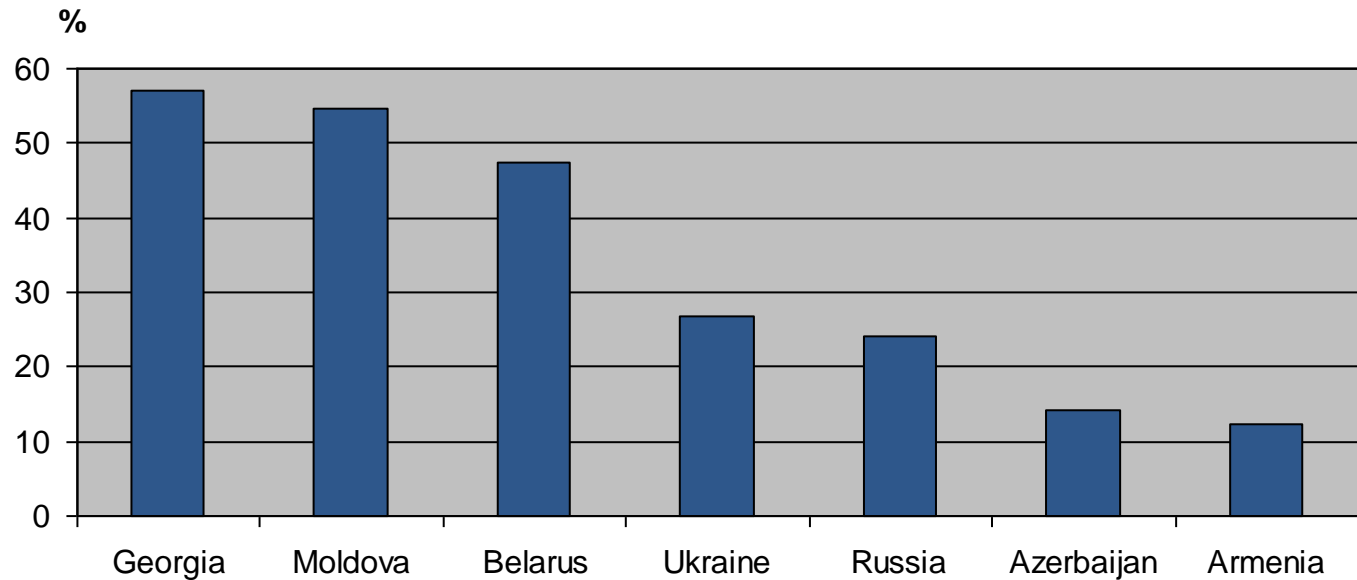

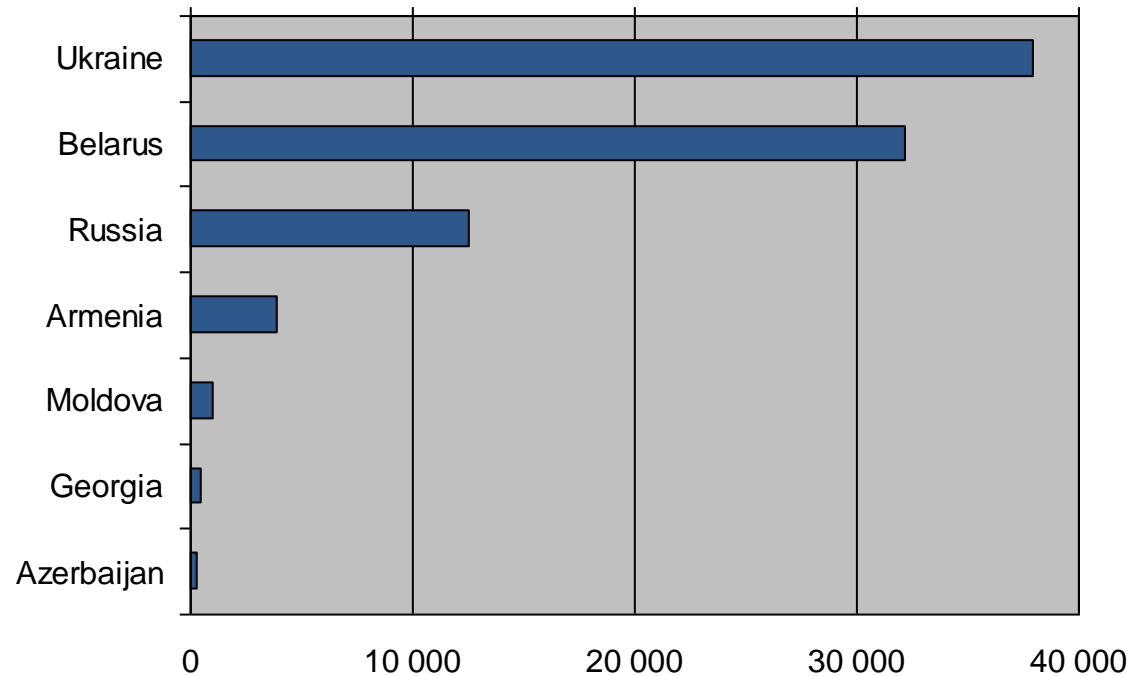
Immigration for permanent residence to Poland, 2010 Percentage of immigrants aged 20-30





Immigration from to Poland: residence permits

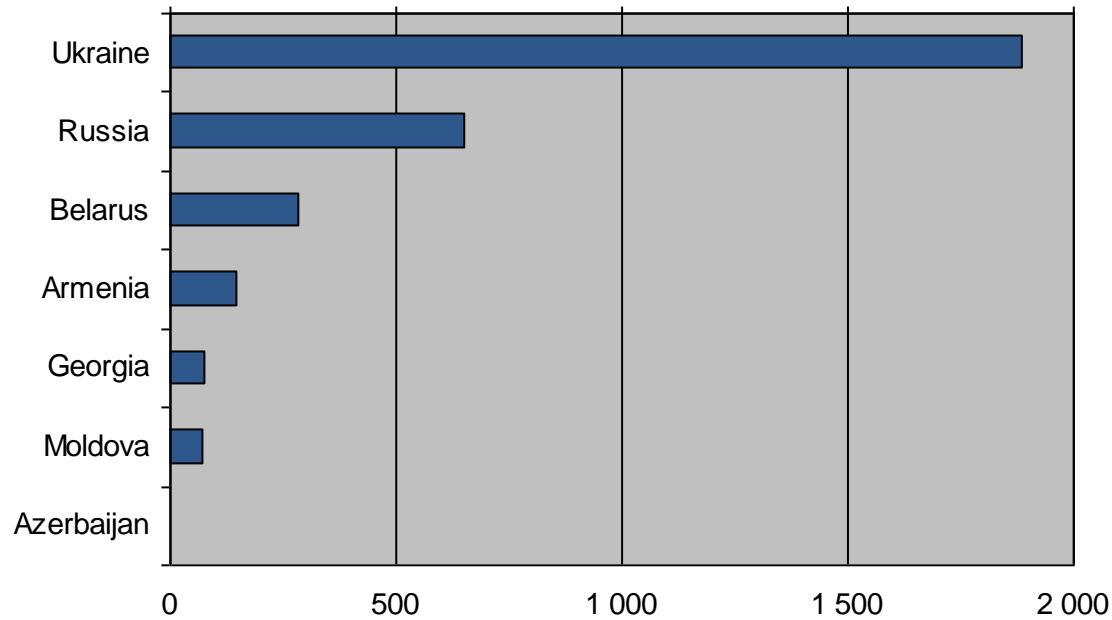
All valid permits to Poland by citizenship, 2010



Total number of all valid permits to Poland in 2010: 130 886, in which EaP+RF constituted 67% (29% - Ukraine, 25% - Belarus).



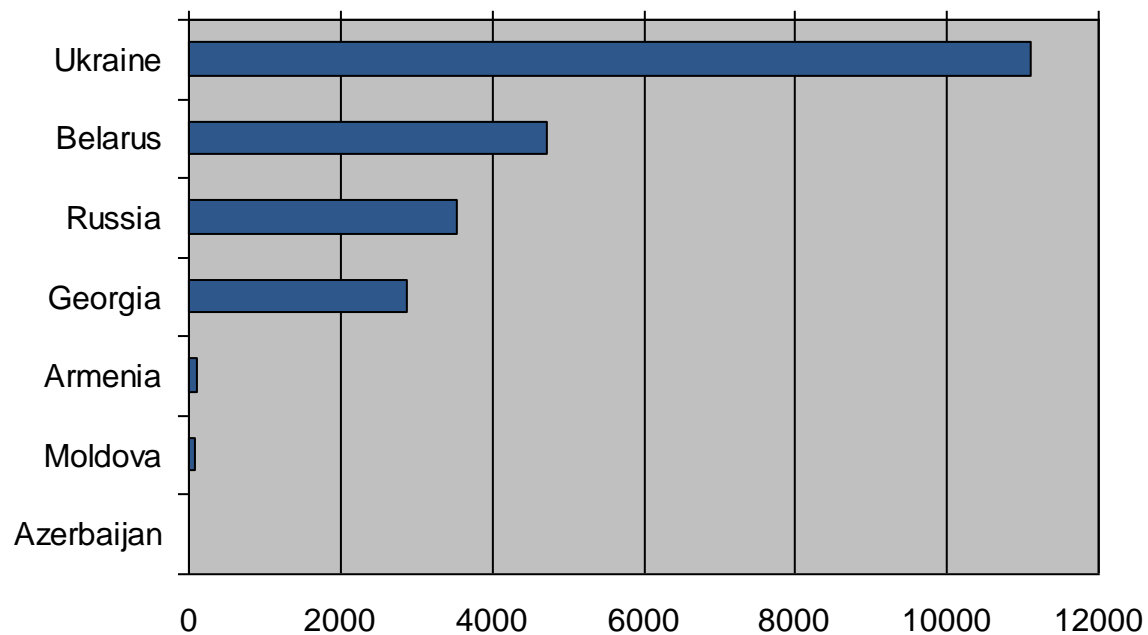
Third country nationals found to be illegally present in Poland, 2010

Third country nationals refused entry at the Polish external borders, 2010

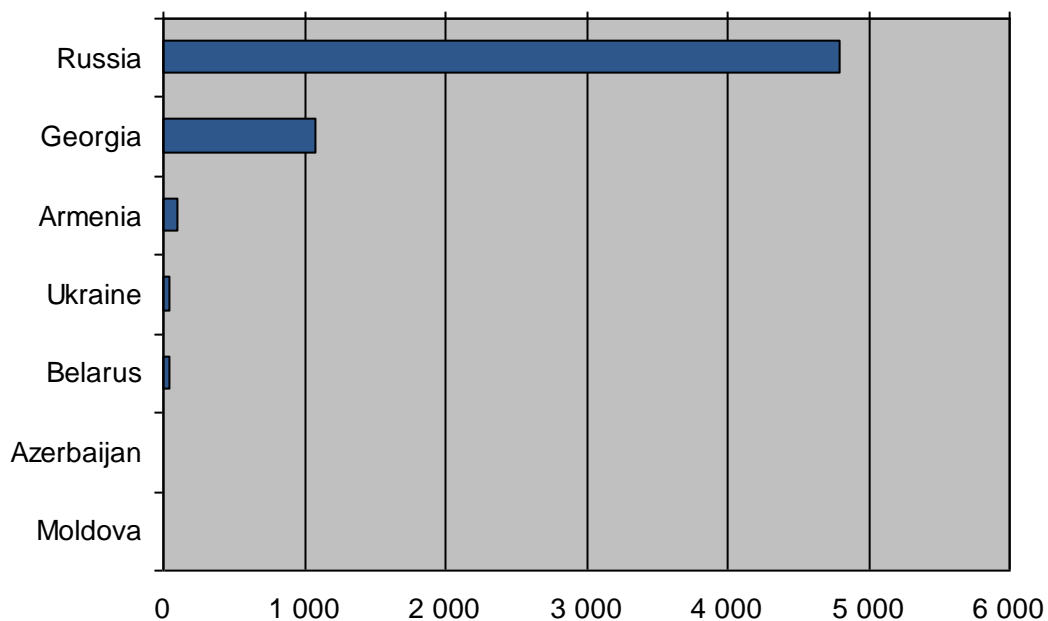

Asylum and new asylum applicants to Poland by citizenship, 2010



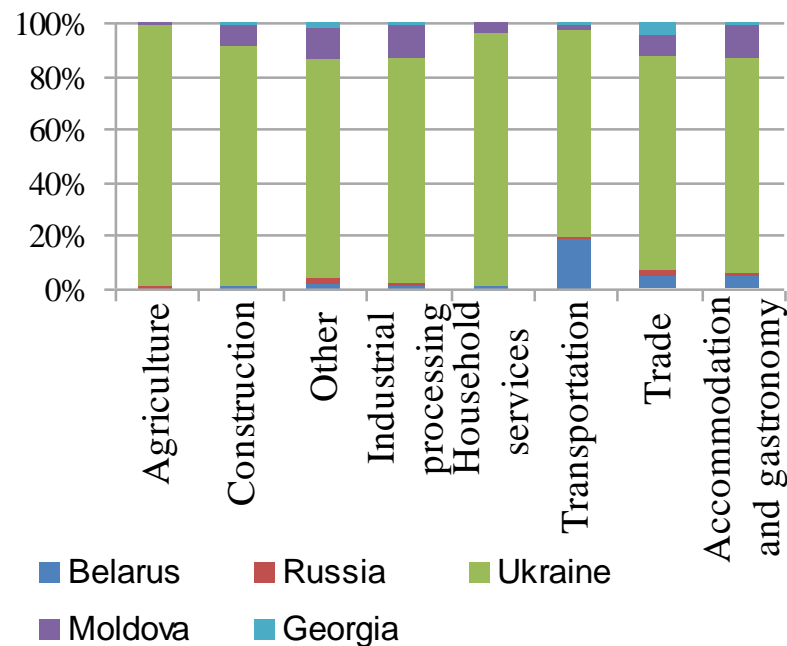
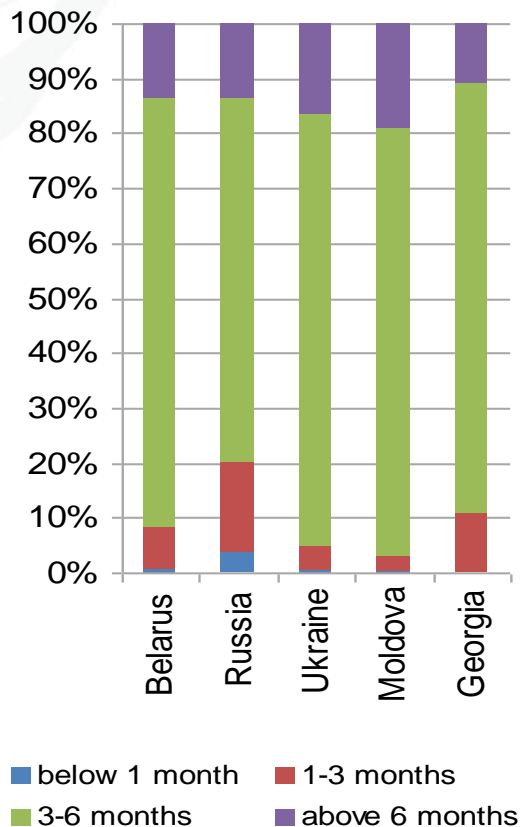
Total number of asylum applicants to Poland in 2010: 6 540.
